Content and Qualification Goals	 Building upon principles acquired in the Bachelor's studies, this module strengthens the techniques of literary analysis as well as the independent study of the interdependency of texts and their contexts. The module serves to put national literatures of the USA and Canada in relation to each other from a historic comparative, integrative, and contrastive perspective, and to critically examine concepts of nation, culture, ethnicity, social class, and gender. Examining American literary history serves as a literary and cultural-historical basis for the student, so that over the further course of study, the student can position him/herself in historical, theoretical, and methodical (interdisciplinary) contexts. The lecture (VL) provides an introductory overview of the varying literary genres, eras, and authors. In the advanced seminar (HS), the student learns the eras, methods, and theories of North American Studies by means of working with literary examples. Exercise Classes (UE/PS) are research-oriented and further develop the student's research and writing capabilities.

Content and Qualification Objectives	 Two advanced seminars (HS) serve to further immerse students in literary studies. (1) By means of diverse and varied literary and cultural examples, a critical look at the literary canon will be a theme, whereby the student learns to scrutinize concepts such as nation, culture, ethnicity, social class, and gender. (2) The student will study several historical, theoretical, and methodical approaches to literature and put them into practice and application. Students will analyze texts on their own and apply the learned concepts and methods of cultural studies. Furthermore, students practice to independently use the available resources for research, and to formulate your own questions and thoughts relevant to the research. Students are also expected to present scholarly research content in a formal and appealing way. Students experience their learning group as a research group, and, as a team, draw from relevant theories to work out interpretation and research approaches to the material.

Content and Qualification Objectives	 Besides introductory methods for the observation and analysis of various cultural phenomena (e.g., film, art, music, architecture), students learn to recognize, describe, and analyze the interrelatedness and effects of culture and literature. This module will address basic principles of scholarly work in the field of <i>North American Studies</i>. Methods of cultural studies in a North American context, with regards to observation and analysis of varying cultural phenomena and artistic genres and their interrelatedness and effects will be imparted to students. An emphasis will be on popular culture, whose phenomena will be analyzed and discussed from an ethnic, gendered, and social point of view. Students are to become acquainted with the plurality of ethnic cultures in North America, and discuss critically their cultural production and contribution to society. Popular culture elements should be perceived as expressions of a pluralistic society. Students practice how to conduct individual research and how to develop a relevant thesis for that research, as well as be able to present their research in an academic and interesting manner. Drawing from relevant theories, students should work in teams to analyze and work on cultural concepts and phenomena.

Content and Qualification Objectives	 Students are to consider the central phenomena and concepts of North American society and history from a historical perspective, as well as recognize their present-day relevance. The perspectives of minorities in society should be perceived within their cultural and political involvements. Cultural practices are analyzed by their artistic, cultural, and political dimensions. Chosen aspects of North American culture and their development are central concepts and theories of North American culture and will be assigned and individually researched. Students practice to conduct their research individually and with the resources made available to them. An important part of the module is how to improve the formulation of a student's independent thesis at an academic level. The emphasis is on group work, in which individual interpretations and approaches to research by means of important theories can be developed.

Students develop an awareness of the complexity of scholarly questions and learn that their multidimensional nature can be examined through trans- and interdisciplinary work. Students become aware that the field of <i>North American Studies</i> has been interdisciplinary since its beginnings. Furthermore, students practice to independently use the available resources for research, and to formulate their own questions and thoughts relevant to the research. Content and Qualification Objectives	 Students learn to pay attention to their perception of gender-specific hierarchical societal structures as well as their corresponding norms, symbols, and regulations in social reality. Students gain insight into the function and construction methods of gender and gender roles as a central integration mechanism for society, culture, and individual identity from a historical and contemporary perspective. Students should also train their critical ability to analyze gender stereotypes in regards to their hierarchical systems and patterns of construction. Students learn to understand gender research as a differentiation process, which occurs as a reaction to the dynamics of societal developments and which is reflected in the contexts of various academic disciplines. Students should receive an overview of the development of gender studies, the current position in gender theory, as well as methods and history of women's studies and gender policies. Students learn to comprehend the intersecting relationships between race, class, and gender, and their significance for the field of North American Studies.

Content and Qualification Objectives	 Media studies and its methods will complement the thus-far explored literary- and cultural studies approaches to North America. In doing so, regard should be given especially to the significance of the diversity of the media in North America and the media's relevance in North America's historical, cultural, social and political development. Students experience and practice North American Studies from the perspective of media studies. Students become aware of the cultural significance of the media, and scrutinize its traditional and new forms both in their historical and theoretical contexts. The goal is to develop a media-critical awareness in the area of North American Studies. Students discuss media culture as both an essential factor in North American public discourse and also as the destination and platform for scholarly discussion and examination. Students learn to analyze the interrelation between North American media culture and topics like Americanization, globalization, and localization.
