### Tasks & Key Points:

- Collaboration in an international research project on “**Comparative Corporate Governance/Disclosure**”, in which the annual reports of the 100 largest companies in the legal form of a publicly-traded corporation in various countries are analyzed based of predefined templates. Thematic focuses include “corporate financing”, “capital markets”, “board structures”, but also areas such as “value-oriented management indicators”, “corporate codes & compliance” and “sustainability disclosure”.
- Compensation based on the usual standard rates for “student assistants” (B.Sc. or M.Sc.) at Philipps University with an initial standard contract of 30 hours/month for a period of six months. Extensions are possible and are generally sought depending on the project requirements.
- Flexible working hours in consultation with the employees of the professorship, which are to be provided primarily on site at the university for content/organizational reasons.

### Your Profile:

- Basic knowledge in the field of Financial Accounting and/or other areas from the field of “Accounting & Finance”, which can be proven e.g. by relevant courses (B.Sc. and/or M.Sc.) or also by practical professional experience.
- Sound knowledge of English, although specific foreign language skills are also desirable and should be stated in the application.
- High degree of initiative, communication and organizational skills as well as the ability to work in a team and social skills.
