The author assures that he/she is entitled to own the rights of use to the work and that he/she has not previously made any conflicting dispositions. He/she declares that the publication of the work does not violate any rights of third parties and indemnifies Marburg University Library (Universitätsbibliothek Marburg) against any claims of third parties. He*she undertakes to inform the University Library (Universitätsbibliothek Marburg) immediately if alleged or actual infringements of third party rights are asserted. In particular, the author grants Marburg University Library (Universitätsbibliothek Marburg) the right,

- (1) to reproduce and store the work on its own servers and to make it accessible via international data networks,
- (2) to pass the work on to the German National Library (Deutsche Nationalbibliothek) as well as to library partner institutions and to grant them the right of permanent storage,
- (3) to migrate the document into other formats,
- (4) to pass on the metadata to databases or directories.

- Unless the author has removed the curriculum vitae, if any, from the electronic version of the work, the author gives his or her consent to the mechanical storage and public availability of the curriculum vitae contained in the document to the public.
- The author wishes to publish the document only after the expiration of an embargo period of six months on the publication server.

For dissertations

- (1) the author assures the conformity of the supplied files with the approved original version and the printed version,
- (2) the first examiner checks the fulfillment of possible conditions and releases the electronic publication by signature.

For examination papers (master's, bachelor's, diploma or master's theses)

- (1) the author assures that the files supplied do not contain any personal data (place and date of birth, e-mail address, matriculation number, etc.), but otherwise correspond to the original version submitted,
- (2) the first reviewer confirms that the work is worthy of publication and that the publication of the work does not violate any rights of third parties (e.g. image rights, personal rights, copyrights and exploitation rights),
- (3) the dean gives permission for publication.
